1. Introduction

1.1 In accordance with the signed Revitalized Agreement on the Resolution of the Conflict in the Republic of South Sudan, the CTSAMVM Technical Committee conducted its first meeting with the representation from the incumbent TGoNU, SPLM/SPLA-IO, SSOA and FDs in Khartoum, Sudan on 26 September 2018.

1.2 The agenda of the meeting consisted of the following: (a) CTSAMM Restructuring to include the tasks of the Area Committees and MVTs; (b) Proposed CTC Terms of reference; (c) CTSAMM reporting; and (d) next meeting.

1.3 The Chair of the meeting provided an opening statement stressing that the first meeting was critical and important to the monitoring and verification body. He added that it is important that the committee know its tasks over the next few months. Also it was important to look at the composition of the sub-bodies of the Area Committees and MVTs.

2. Agenda Items

2.1 **CTSAMVM Restructuring:** CTSAMVM Technical Committee (CTC) deliberated on the CTSAMVM restructuring and reviewed the draft of the terms of reference and duties of CTC, Area Committees, MVTs and they decided to:

- Review the structure, the composition, the tasks, the duties, the concept of operations and come up with developed proposals based on the comments of the parties;

- Each party except the FDs shall provide the required numbers of representatives for CTC as follows:
 - 3 senior military officers;
 - 1 senior police officer;
 - 1 senior National Security Officer;
 - 1 liaison officer.
- FDs shall provide one senior officer for CTC.
- Each party shall provide two senior officers between the rank (Lt Col – Col) for each of the three Sectors/Area Committees;
- Each party shall provide a national monitor with the rank (Capt – Maj) for each of the twelve MVTs.

2.2 **Terms of Reference of CTC:** CTSAMVM Technical Committee deliberated on the proposed terms of reference and decided to:

- Review the developed proposal and amend it to conform with the Revitalized Agreement;
- The amended terms of reference and approved organizational chart shall be distributed to the parties prior to the next meeting.

2.3 **CTSAMVM Reporting:** The reports officer provided a presentation on the way of reporting and the committee deliberated and decided to review the chain of command and the relationship at the horizontal and vertical level at the coming CTC meeting.

2.4 **Date of next meeting:** As per the agreement, the CTC decided to have its next meeting on 10 and 11 October 2018 in Khartoum, Sudan.

The meeting then adjourned and signed the above decisions.
